

CHARDON MUNICIPAL COURT BOND SCHEDULE

- Bond may **NEVER** be posted with a check.
- Bond may be posted via: cash, surety, Visa, MasterCard, and Discover

▪ Violation of Probation	No Bond Allowed
▪ Contempt / Failure to Appear	No Bond Allowed
▪ Violation of Temporary Protection Order	No Bond Allowed
▪ Any Felony Charge	No Bond Allowed
▪ Domestic Violence	No Bond Allowed
▪ Assault	\$750.00
▪ Flee & Elude	\$750.00
▪ Theft	\$500.00
DRIVING OFFENSES	
▪ Driving Under OVI Suspension 4510.14	\$500.00
All other violations listed as unclassified under 4510.037 through 4510.44 will require a bond only if there are prior convictions under these sections.	
▪ Driving While Under the Influence (OVI)	\$750.00
2 or more in 10 years	\$1,000.00
▪ Physical Control	\$500.00
CRIMINAL CHARGES NOT LISTED	
▪ 1 st Degree Misdemeanor	\$500.00
▪ 2 nd Degree Misdemeanor	\$500.00
▪ 3 rd Degree Misdemeanor	\$250.00
▪ 4 th Degree Misdemeanor	\$250.00

UNCLASSIFIED OFFENSES and MINOR MISDEMEANORS DO NOT REQUIRE BOND UNLESS A WARRANT IS ISSUED FOR FAILURE TO APPEAR.

BENCH WARRANTS

Contempt Warrants

- If there is a bond amount listed, that amount can be taken for payment of costs and fines and no court date is needed.
- If there is a **NO BOND ALLOWED** listed, the defendant will come before the Judge at the next available court date.
- There is **NO BOND ALLOWED** for a warrant issued for violation of probation.

Failure to Appear

- **NO BOND** can be set if the person failed to appear for trial or failed to appear for jail.
- Bond can be set if the person failed to appear for arraignment
 - If the original charge is **no seat belt or prohibited parking** a \$200.00 bond can be taken and no court date is needed.
 - Refer to the above listed **Miscellaneous Offenses, Driving Offenses, and Charges not listed** to set bond on other original charges and the court date is to be set within three (3) business days at (8:00 am) 0800.
 - Failure to appear on a minor misdemeanor is \$250.00

Warrant on Complaint

- Refer to the above listed **Miscellaneous Offenses, Driving Offenses, and Charges not listed**.

BOND WILL BE ADDRESSED WITH THE PRESIDING JUDGE IN COURT OR BY VIDEO IF NOT POSTED AT JAIL.
